

**ENDURA LIFETIME LIMITED WARRANTY**

Thank you for purchasing Innovation Cabinetry, LLC's high-quality cabinetry products! We trust that our products will bring you many years of outstanding service and appearance.

Innovation Cabinetry, LLC warrants that Endura cabinetry products shall be free from defects in material and workmanship under the following conditions:

This Warranty applies only to first quality High-Density Polyethylene (HDPE) cabinet carcasses, doors, drawers, and shelves manufactured by Simmerty Manufacturing, LLC for Innovation Cabinetry, LLC purchased from an authorized retailer. It is only applicable to properly installed products used in residential applications within the United States by the original purchaser, and it is not transferable. Hinges, leveling legs, and factory-installed hardware are provided with a 5-Year Limited Warranty subject to the same conditions, exclusions, and limitations detailed herein.

This Warranty does not cover normal wear and tear, accidents, spills, improper cleaning, misuse, improper installation, abuse, accidents, negligence, alterations, unauthorized repairs, commercial use, exposure or contact with caustic chemicals, and any other cause of damage unrelated to a defect in workmanship or material. In addition, environmental conditions, lighting, and surrounding colors can affect the perception of the colored finish, and sunlight and other conditions can cause natural aging of the finish. These are not defects covered by this Warranty.

Under the terms of this Warranty, Innovation Cabinetry, LLC, in its sole discretion, will determine the appropriate remedy and will either repair or replace the defective item or parts. Refunds are generally not available. Innovation Cabinetry, LLC cannot guarantee that these replacements will match the residential application's original components' colors, hues, sheens, textures, finish, or appearance.

The repair or replacement of an item or part does not extend the duration of the warranty period or start a new warranty period. In-home inspection fees, transportation of the product to and from the retail store, and to and from Innovation Cabinetry, LLC, if required for repairs are the responsibility of the purchaser.

HDPE is a manufactured product sourced by Simmerty Manufacturing, LLC. Colors are subject to availability and may be changed or discontinued over time. Innovation Cabinetry, LLC reserves the right to alter design, specifications, and material without obligation to make similar changes to products previously manufactured.

If a warranty claim is filed after a product or color is discontinued, Innovation Cabinetry, LLC reserves the right to honor the Warranty in one of the following fashions:

- To replace the affected component with a new component of the same style.
- To replace the affected component and any other component(s)

in the residential application to achieve a reasonably uniform appearance with a similar and comparable product style to the initially purchased style.

- Refund the purchase price of the defective component.

This Warranty is provided only under the following conditions:

- Proper safeguards are incorporated in the use and care of cabinets in accordance with local building codes and Innovation Cabinetry's Installation Guide and Cabinet Cleaning and Care Guidelines including:

1. Proper installation
2. Protection against contact with extreme heat and harmful substances.
3. Adherence to appliance manufacturers' specifications for installation and ventilation of cabinets.

This Warranty shall become void if the cabinets are in any way modified, improperly installed, or damaged before or during the installation process.

THE LIMITED WARRANTY IS THE EXCLUSIVE WARRANTY OF INNOVATION CABINETRY, LLC. THIS LIMITED WARRANTY IS EXTENDED IN LIEU OF AND TO THE EXCLUSION OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL INNOVATION CABINETRY, LLC'S LIABILITY EXCEED THE BUYER'S PURCHASE PRICE. THE LIMITED WARRANTY RUNS ONLY TO THE ORIGINAL END-USER OF THE PRODUCTS. THE LIMITED WARRANTY IS NOT INTENDED TO, AND DOES NOT, RUN TO ANY SUBSEQUENT BUYER OR END-USER, NOR TRANSFERRED TO ANY OTHER PERSON, UNLESS OTHERWISE SPECIFICALLY STATED IN WRITING BY AN OFFICER OF INNOVATION CABINETRY, LLC. IN NO EVENT SHALL INNOVATION CABINETRY, LLC BE LIABLE TO THE END-USER OR ANY THIRD PARTY FOR SPECIAL, COLLATERAL, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES.

- Replacement of affected cabinet/s, parts, or components is at the sole discretion of Innovation Cabinetry, LLC.
